Additional sessions will be held every other Friday at 9:00. Registration lists for December and January sessions are filling up. An application update will be provided starting in January 2014.

## Staff

There is one staff opening remaining to be filled: Special Education Paraprofessional.

The staff and some Fraser Academy families provided, prepared, served and cleaned up a delicious turkey and ham with all the trimmings dinner. # Program
